**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is made as of March 15, 2011 ("Effective Date") by **GENERAL ELECTRIC CAPITAL CORPORATION**, in its capacity as collateral agent for the Secured Creditors ("Grantee"), in favor of each of **CT TECHNOLOGIES INTERMEDIATE HOLDINGS, INC.**, a Delaware corporation ("Borrower"), **CT TECHNOLOGIES INTERMEDIATE HOLDINGS (TOPCO), INC.**, a Delaware corporation ("Holdings"), and each of the undersigned direct or indirect Subsidiaries of Borrower (collectively, together with Borrower and Holdings, the "Grantors" and each, individually, a "Grantor"). All capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Credit Agreement or the Intellectual Property Security Agreement (as defined below).

**WHEREAS**, Borrower is party to that certain Credit Agreement, dated as of September 22, 2008, by and among such Borrower, the Credit Parties signatory thereto, Grantee, acting in its capacity as agent for the lenders (the "Agent"), and the lenders party thereto from time to time (the "Lenders") (as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement");

**WHEREAS**, Borrower's indebtedness and obligations to the Lenders and the Agent under the Credit Agreement were guaranteed by the other Grantors pursuant to the Credit Agreement and the Holdings Guaranty and Subsidiary Guaranty (as defined in the Credit Agreement);

**WHEREAS**, in connection with that certain Security Agreement, dated as of September 22, 2008 (as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement"), each Grantor entered into that certain Intellectual Property Security Agreement, dated as of September 22, 2008 (as from time to time amended, restated, supplemented or otherwise modified, the "Intellectual Property Security Agreement"), by and among each Grantor and Grantee, acting in its capacity as the Collateral Agent for the Secured Creditors, pursuant to which each Grantor mortgaged, pledged and hypothecated to Grantee (for itself and the benefit of the Secured Creditors) a security interest in and Lien upon all of such Grantor's right, title and interest in, to and under the Intellectual Property Collateral (under and as defined in the Intellectual Property Security Agreement), including, but not limited to, the Patents and Trademarks identified on Exhibits A and B attached hereto (the "Released Intellectual Property Collateral");

**WHEREAS**, the Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on September 23, 2008 at Reel 003857, Frame 0381 with respect to the trademark registrations and applications owned by Grantors; and

**WHEREAS**, pursuant to the terms and conditions of that certain payoff letter, dated as of the date hereof, by and among Grantee, Grantors and the other Credit Parties party thereto, Grantee (on behalf of itself and the Secured Creditors) has consented to the release of its security interest in and Lien upon the Released Intellectual Property Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee (on behalf of itself and the Secured Creditors) hereby terminates and releases all of its and the Secured Creditors' security interest in and Lien upon the Released Intellectual Property Collateral granted pursuant to the Security Agreement and the Intellectual Property Security Agreement. Without limiting the generality of the foregoing, the Grantee (on behalf of itself and the Secured Creditors) releases any security interest it may have in the Released Intellectual Property Collateral by virtue of the Security Agreement and the Intellectual Property Security Agreement.

2. To the extent Grantee retains any such interest, Grantee hereby assigns, transfers and conveys to Grantors, any and all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and security interest and collateral assignment in the Released Intellectual Property Collateral. Such assignment, transfer and conveyance by Grantee is made without any representation or warranty (express or implied) by Grantee.

3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of Grantors.

4. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. Delivery of an executed counterpart of a signature page to this Release by facsimile or other electronic transmission shall be effective as delivery of a manually executed counterpart of this Release.

5. THIS RELEASE SHALL BE DEEMED TO BE A CONTRACT MADE UNDER AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK WITHOUT GIVING EFFECT TO THE PRINCIPLES OF CONFLICT OF LAWS THAT WOULD APPLY THE LAWS OF ANOTHER JURISDICTION.
