

AND said Michael Angelo Enterprises, Inc. , for itself, its heirs, assigns, and legal representatives, hereby covenants to and with Assignee Toomey Inc., its assigns, successors and legal representatives, that it has full right to sell and assign the entire interest in and to said invention and the Letters Patent to be had therefor and that the entire interest herein conveyed is free from all prior assignment, grant, mortgage, license or other encumbrance whatsoever.

AND the undersigned does hereby authorize and request the Commissioner of Patents and Trademarks to record title to said Trademark and the registration thereon to said **Toomey Inc.** as the assignee of the entire right, interest, and title therein.
