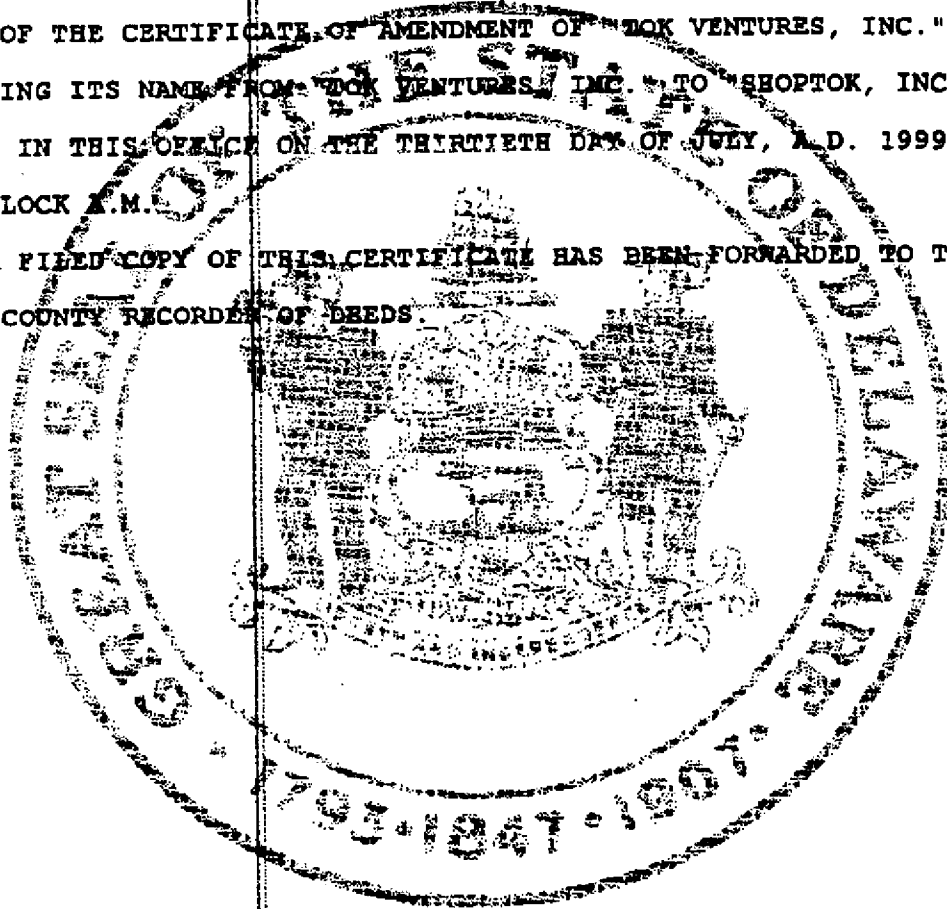

SECOND: That Article I of the Certificate of Incorporation of this corporation is amended to read in its entirety as follows:


The name of the corporation is ShopTok, Inc.


