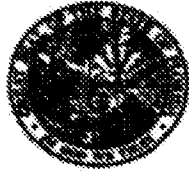

AMENDMENT TO ARTICLES OF INCORPORATION
OF
SUNBELT SOFTWARE DISTRIBUTION, INC.

WHEREAS, the Articles of Incorporation for Sunbelt Software Distribution, Inc. (the "Company") were filed with and approved by the Secretary of State of Florida on the 7th day of January, 1994; and

WHEREAS, an Amendment to the Articles of Incorporation for the Company were filed with and approved by the Secretary of State of Florida on the 20th day of January, 1998; and

WHEREAS, an Amendment to the Articles of Incorporation for the Company were filed with and approved by the Secretary of State of Florida on the 18th day of January, 2000; and

WHEREAS, an Amendment to the Articles of Incorporation for the Company were filed with and approved by the Secretary of State of Florida on the 10th day of June, 2003; and

WHEREAS, it is the intention of all of the directors and a majority of the stockholders of the Company that the Articles of Incorporation be amended in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, the proposed Amendment to the Articles of Incorporation of the Company hereinafter set forth was approved and adopted by all of the stockholders and directors of the Company pursuant to the provisions of Florida Statutes Sections 607.0704 and 607.0821 on the 4th day of February, 2008; and

WHEREAS, the approval of the Secretary of State of Florida of the proposed Amendment hereinafter set forth is hereby requested.

NOW, THEREFORE, the Articles of Incorporation of the Company are hereby amended, by deleting in its entirety the present Article I and by substituting therefor the following, to wit:

"ARTICLE I
NAME

The name of this corporation shall be: SUNBELT SOFTWARE, INC.

The principal office and mailing address of this corporation shall be 33 N. Garden Avenue, Suite 1200, Clearwater, Florida 33755."

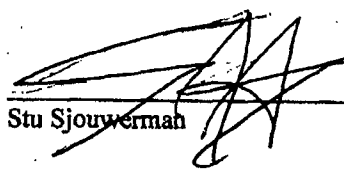

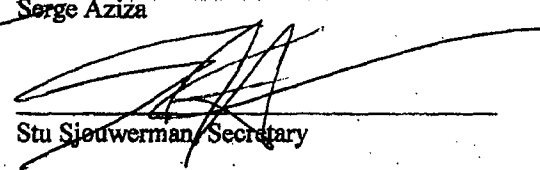
