TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made as of October 25, 2007 by Oxford Industries, Inc., a Georgia corporation, with its principal place of business at 222 Piedmont Avenue, NE, 5th Floor, Atlanta, Georgia 30308 ("Assignor"), to Willis & Walker, Inc., a Georgia corporation, with its principal place of business at 75 Bennett Street, Atlanta, Georgia 30309 ("Assignee").


WHEREAS, Assignor owns the trademark WILLIS & WALKER (hereinafter, the "Mark") which is registered on the Principal Register of the United States Patent and Trademark Office as Registration No. 3210854 (hereinafter, the "Registration");

WHEREAS, Assignee desires to acquire the entire right, title, interest and goodwill in and to the Mark and the Registration;


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers, and conveys to Assignee all right, title, and interest, throughout the world, in and to the Mark and the Registration, together with the goodwill of the business symbolized by the Mark, and all rights of action accrued and to accrue under and by virtue thereof, including the right to sue and recover for past, present and future infringement. Assignor agrees that it shall, without additional compensation, execute and deliver any further instruments or documents, and take all such further reasonable action, as Assignee may request, including procuring assurance and cooperation from Assignor's officers and employees, in order to transfer to and vest in Assignee all right, title, and interest in and to the Mark and the Registration. Assignor hereby irrevocably appoints Assignee as its power-of-attorney, effective as of the date hereof, with full right of substitution, for the purpose of executing such documents and taking such other actions as may be reasonably necessary to effectuate the purpose of this Assignment. This power-of-attorney shall be for the benefit of Assignee, its licensees, successors, and assigns, and is coupled with an interest.
