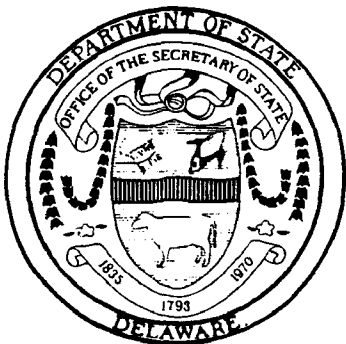

ARTICLES OF MERGER
PURSUANT TO SECTION 351.458
OF THE REVISED STATUTES OF MISSOURI

Pursuant to the provisions of The General and Business Corporation Law of Missouri, the undersigned corporations certify the following:

1. Rockwood Computer Corporation, a Delaware corporation ("Rockwood"), and Atlas Plastics Corporation, a Missouri corporation ("Atlas"), are hereby merged and Rockwood is the surviving corporation.
2. On June 27, 1988 the board of directors of Rockwood by duly adopted resolution approved the Plan of Merger set forth in these articles.
3. On June 27, 1988 the board of directors of Atlas by duly adopted resolution approved the Plan of Merger set forth in these articles.
4. This Plan of Merger has been adopted pursuant to Section 351.458 RSMo.
5. PLAN OF MERGER
 - (a). Rockwood is the surviving Corporation.
 - (b). All of the property, rights, privileges, leases and patents of Atlas are to be transferred to and become the property of Rockwood, the surviving Corporation. The officers and board of directors of the above named corporations are authorized to execute all deeds, assignments, and documents of every nature which may be needed to effectuate a full and complete transfer of ownership.

- (c). Each common share of Atlas outstanding immediately prior to the merger, and all rights in respect thereof by virtue of the merger and without any act on the part of the holder thereof, shall be converted into 1/2500 of a fully paid and non-assessable share of Rockwood, except that when a fractional share results from the merger, no fractional shares will be issued but each shareholder of a fractional share will receive the cash equivalent to the value of such fractional share.
- (d). The officers and board of directors of Rockwood shall continue in office until their successors are duly elected and qualified.
- (e). It is agreed that, upon and after the issuance of a certificate of merger by the Secretary of State of the State of Missouri:
 - (i). The surviving corporation may be served with process in the State of Missouri in any proceeding for the enforcement of any obligation of any corporation organized under the laws of the State of Missouri which is a party to the merger and in any proceeding for the enforcement of the rights of a dissenting shareholder of any such corporation organized under the laws of the State of Missouri against the surviving corporation;
 - (ii). The Secretary of State of the State of Missouri shall be and hereby is irrevocably appointed as the agent of the surviving corporation to accept service of process in any such proceeding; the address to which the service of process in any proceeding shall be mailed is The Corporation Trust Company, 314 North Broadway, St. Louis, MO 61302;
 - (iii). The surviving corporation will promptly pay to the dissenting shareholders of any corporation organized under the laws of the State of Missouri which is a party to the merger the amount, if any, to which they shall be entitled under the provisions of The General and Business Corporation Law of Missouri with respect to the rights of dissenting shareholders.

- (f). The name of the surviving Corporation shall be Rockwood Computer Corporation.
- 6. The number of shares outstanding of Atlas is 2,139,712, and the number of shares outstanding of Rockwood is 27,400.
- 7. The number of shares Rockwood has authority to issue is 40,000.
- 8. The plan of merger was approved by unanimous consent of the shareholders of each of Atlas and Rockwood.




