This Memorandum of Merger is executed as of this 9th day of March 2011 by Cheryl L. Barr, Assistant Secretary, L-3 Services, Inc.:

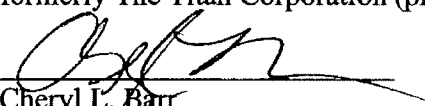
