

11. SECURITY INTEREST

(a) Grant of Security Interest.

(i) To secure the prompt, punctual and faithful payment of all obligations due under this Agreement (including, without limitation, the timely payment of the Consideration and any indemnification obligations hereunder) to Lenders, Windmill hereby grants to Lenders, as secured party, for the benefit of Lenders and any affiliate of Lenders, a continuing security interest in and to, and assigns to Lenders the following, and each item thereof, whether now owned or now due, or in which Windmill has an interest, or hereafter acquired, arising or to become due, or in which Windmill obtains any right, title and interest: all products, proceeds, substitutions, and accessions of or to any and all of the Trademarks, and any and all trademarks, service marks, trade names, trade styles, trade dress, designs, and stylizations derived from the Trademarks and/or combined therewith registered, subject to an application or otherwise recognized in the United States of America or in any state or territory therein or in any foreign country, and the goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof, or otherwise, and all reissues, extensions or renewals thereof and any agreement, written or oral, providing for the grant or license by Windmill of any right to use any or all of the Trademarks or any trademark, service marks, trade names, trade styles, trade dress, designs, or stylizations derived from the Trademarks and/or combined therewith (all of which, together with any other property in which Lenders may in the future be granted a security interest, is referred to herein as the "Collateral"). All terms used in this Section 11, and not otherwise defined in this Agreement, shall have the meanings given to them in the California Uniform Commercial Code.
