2. Assignor hereby assigns, sells, transfers and sets over unto Assignee all claims for damages for reason of past infringement of the Trademarks, as well as the right to sue for and collect the same for its own use and enjoyment, without further obligation to Assignor with respect thereto.



signee, its successors, legal representatives and assigns in accordance with the terms of this instrument.


