Assignment of Trademarks

ASSIGNMENT OF TRADEMARKS made as of the 25th day of May 2010, by Milliken & Company, a Delaware corporation ("Assignor"), to Pym Consumer USA Inc., a South Carolina corporation ("Assignee").

RECITAL

Assignee and Assignor are parties to a Sale Agreement dated the date hereof (the "Sale Agreement"), pursuant to which Assignor has agreed to sell to Assignee and Assignee has agreed to buy from Assignor the Assets (as defined in the Sale Agreement). In accordance therewith, Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under Assignor's registered trademark listed on Schedule A annexed hereto and incorporated herein by reference (the foregoing being referred to herein as the "Mark").

NOW, THEREFORE, Assignor, for and in exchange for the payment of the consideration set forth in the Sale Agreement, the receipt of which is hereby acknowledged, does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under the Mark, together with the goodwill of the business associated therewith and which is symbolized thereby, all rights to sue for infringement of the Mark, whether arising prior to or subsequent to the date of this Assignment of Trademarks, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, Canada and in any other jurisdiction, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment of Trademarks not been made.

Notwithstanding anything to the contrary herein, Assignor and Assignee are executing and delivering this Assignment in accordance with and subject to all of the terms and provisions of the Sale Agreement. Without limiting the foregoing, the transfers provided for herein are made without representation or warranty of any kind and Assignee hereby accepts the Mark "AS IS," "WHERE IS," and "WITH ALL FAULTS."

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Trademarks shall be governed by and construed in accordance with the laws of the State of South Carolina without giving effect to the principles of conflicts of laws thereof.
