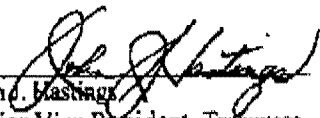
FIRST: The name of the limited liability company (hereafter called the "limited liability company") is Humphreys Accessories LLC.
