GRANT OF SECURITY INTEREST
(TRADEMARKS)

THIS GRANT OF SECURITY INTEREST, dated as of February 24, 2011 is executed by ANDA NETWORKS, INC., a Delaware corporation ("Grantor"), in favor of EKinops CORPORATION, a Delaware corporation ("Secured Party"). Unless otherwise defined herein, all other capitalized terms used herein and defined in the Loan and Security Agreement (defined below) shall have the respective meanings given to those terms in the Loan and Security Agreement.

A. Pursuant to that certain Loan and Security Agreement, dated as of February 4, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan and Security Agreement"), between the Grantor and the Secured Party, the Secured Party has agreed to extend loans to the Grantor upon the terms and subject to the conditions set forth therein.

B. The Grantor has adopted, used and is using the trademarks, more particularly described on Schedule 1 annexed hereto and made a part hereof, which trademarks are registered or subject to an application for registration in the United States Patent and Trademark Office (collectively, the "Trademarks").

C. Pursuant to the Loan and Security Agreement, the Grantor has granted to the Secured Party a security interest in all right, title and interest of the Grantor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the customer lists and records related to the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Obligations.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantor does hereby further grant to the Secured Party a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Secured Party with respect to the security interest in the Collateral granted hereby are more fully set forth in the Loan and Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. This Grant of Security Interest is subject to the letter agreement, dated as of February 21, 2011, between Grantor and Secured Party.


