TERMINATION OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

October 20, 2010

WHEREAS, each of ATTENTI LTD. (formerly known as Dmatek Ltd.), a company incorporated in Israel, PRO TECH MONITORING, INC., a Delaware corporation, and ELMO-TECH LTD., a company incorporated in Israel (individually, a "Grantor", and collectively, the "Grantors"), had granted to SILICON VALLEY BANK, as Administrative Agent (in such capacity, the "Secured Party"), a security interest (the "Security Interest") in such Grantor's trademarks and trademark applications (collectively, the "Trademarks") and the goodwill associated therewith pursuant to, among other things, that certain Trademark Security Agreement dated October 21, 2009 (the "Agreement") by and among the Grantors and the Secured Party, as Assignee, which was filed at the United States Patent and Trademark Office on October 26, 2009 and recorded on Reel 4085, Frame 0382; and

The Secured Party agrees that, upon request of the Grantors or any successor-in-interest or assignee thereof, and at the Grantors' expense, the Secured Party will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantors, or any successor-in-interest or assignee thereof, to effectuate the release of interests contemplated herein.
