**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (the “**Release**”) dated as of March 22, 2011 (the “**Effective Date**”), by and between **STEEL CITY CAPITAL FUNDING, LLC** (the “**Lender**”), and **FORTESSA, INC.**, a Virginia corporation (“**FUSA**”), **FORTESSA INTELLECTUAL PROPERTY, LLC**, a Virginia limited liability company (“**FIP**”), **STERLING HOUSEWARES LLC**, a Virginia limited liability company (“**Sterling**”), and **ESCHENBACH, USA, INC.**, a Virginia corporation (“**EUSA**,” collectively with FUSA, FIP, and Sterling, the “**Borrowers**,” and, individually, each may be referred to as a “**Borrower**”).

**BACKGROUND**

**WHEREAS**, Lender and Borrowers were parties to that certain Term Loan and Security Agreement dated July 17, 2007 (the “**Loan Agreement**”), and that certain Intellectual Property Security Agreement dated July 17, 2007 (the “**IP Security Agreement**”);

**WHEREAS**, pursuant to the Loan Agreement and the IP Security Agreement, the Borrowers granted to the Lender a security interest in and lien on, and collaterally assigned to the Lender all of its trademarks, trademark registrations, patents, copyrights, and associated goodwill, including, without limitation, those trademarks, patents, and copyrights identified on **Schedule 1** (the “**Named Intellectual Property**”); and

**WHEREAS**, the Lender previously agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Intellectual Property.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Lender and the Borrowers agree as follows:

1. **Incorporation of Recitals**. This Release’s Recitals are incorporated into this Release and are deemed to be restated in their entirety in this **Section 1**.
2. **Release and Assignment**. The Lender terminates and releases its security interest in and lien on all of the Named Intellectual Property, and the Lender assigns and transfers to each respective Borrower, without recourse, all of the Lender’s right, title and interest in and to each of the Named Intellectual Property and the related trademark, patent, and copyright registrations and goodwill, effective as of the date set forth above.
3. **Acknowledgment and Acceptance**. The Borrowers acknowledge and accept the foregoing release and assignment by the Lender.
4. **Further Assurances**. The Lender will execute or cause to be delivered to the Borrowers such instruments and other documents, and will take such other actions, as the Borrowers may reasonably request at any time for the purpose of carrying out or evidencing any of the provisions of this Release.


