**ACKNOWLEDGMENT OF RELEASE
OF
INTELLECTUAL PROPERTY COLLATERAL LIEN**

THIS ACKNOWLEDGMENT OF RELEASE OF INTELLECTUAL PROPERTY COLLATERAL LIEN (this "**Release**") is dated as of January 27, 2011 and is made by CapitalSource Finance LLC, a Delaware limited liability company, as administrative agent for the Lenders under the Loan and Security Agreement described below ("**Secured Party**").


WHEREAS, all obligations of Grantors to Secured Party under the Loan and Security Agreement have been satisfied.




