**QUITCLAIM ASSIGNMENT AND RELEASE OF TRADEMARK
COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT**

This agreement dated Feb. 17, 2011, is by and between Steinway, Inc. ("Steinway") and Bank of America Corporation ("Bank of America"), successor in interest to Stanchart Business Credit Inc. ("Stanchart").

Whereas, Stanchart, by Assignment of the Trademark Collateral Assignment and Security Agreement recorded in the US Patent and Trademark Office at Reel/Frame 0783/0482, has been granted a security interest in certain trademarks, as shown in Exhibit A hereto (the "Trademarks");


Whereas, the parties confirm that the Trademark Collateral Assignment and Security Agreement (the "Agreement") recorded in the US Patent and Trademark Office at Reel/Frame 0592/0865, as assigned to Stanchart, was intended solely as a grant of a security interest in the Trademarks, and not as an assignment of any ownership interest of any kind in the Trademarks.

For good and valuable consideration, the receipt and sufficiency of which is acknowledged, the parties hereby agree as follows:

1. To the extent that the Agreement may be interpreted in any manner as a transfer or assignment of any ownership rights in the Trademarks, to remove any doubt, Bank of America hereby confirms that it currently holds no, and has not held in the past, any ownership rights of any kind in the Trademarks, and that it quitclaims any such ownership rights.
2. Bank of America hereby terminates the Agreement, releases the security interest relating to the Trademark and otherwise assigns, grants and conveys to Steinway, Inc. any and all rights Bank of America may have in or to the Trademarks pursuant to the Agreement.
