IP SUPPLEMENT

This IP SUPPLEMENT, dated March 25, 2011, is delivered pursuant to and supplements (i) the Security Agreement, dated as of July 26, 2007 (as it may be from time to time amended, modified, restated or supplemented, the "Security Agreement"), among Isle of Capri Casinos, Inc., a Delaware corporation (the "Grantor"), the other grantors named therein and Wells Fargo Bank, National Association (as successor to Credit Suisse AG, Cayman Islands Branch (f/k/a Credit Suisse, Cayman Islands Branch)), as Secured Party, and (ii) the Grant of Trademark Security Interest dated as of July 26, 2007 (the "Grant") executed by Grantor. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Grant.


