**ASSIGNMENT OF SECURED PARTY'S INTEREST  
(Trademarks - Isle of Capri Casinos, Inc.)**

This Assignment of Secured Party's Interest (this "Assignment") is made as of this 25th day of March, 2011, by Credit Suisse AG, Cayman Islands Branch (f/k/a Credit Suisse, Cayman Islands Branch) in its capacity as resigning Administrative Agent for and representative of the Lenders and any Hedge Provider (each as defined in the below-defined Security Agreement) ("Assignor"), in favor of Wells Fargo Bank, National Association in its capacity as successor Administrative Agent for and representative of the Lenders and any Hedge Provider (each as defined in the below-defined Security Agreement) ("Assignee").

**RECITALS**

A. Isle of Capri Casinos, Inc., a Delaware corporation ("Grantor"), has previously granted to Assignor, as Administrative Agent for and representative of the Lenders and any Hedge Provider (each as defined in the below-defined Security Agreement) a security interest in Grantor's right, title and interest in and to the registered trademarks set forth on Schedule A hereto (the "Trademarks") pursuant to (i) a Security Agreement, dated as of July 26, 2007 (as it may be from time to time amended, modified, restated or supplemented, the "Security Agreement"), and (ii) a Grant of Trademark Security Interest, dated as of July 26, 2007 (the "Grant"), which security interests were recorded on July 27, 2007 in the Assignment Branch of the U.S. Patent & Trademark Office at Reel 3588, Frame 0958.

B. Pursuant to that certain Successor Agent Agreement, dated as of March 25th, 2011, among Assignor, Assignee, Grantor and Requisite Lenders (as defined in the Credit Agreement (as defined in the Security Agreement)), Assignor resigned as the "Administrative Agent" under the Credit Agreement and the other Loan Documents (as defined in the Credit Agreement) (including the Security Agreement), and Assignee was appointed by Requisite Lenders as the "Administrative Agent" under the Credit Agreement and the other Loan Documents (including the Security Agreement).

C. Assignor is executing this Assignment in connection with such resignation by Assignor as the "Administrative Agent" under the Credit Agreement and the other Loan Documents (including the Security Agreement) and such appointment by Requisite Lenders of Assignee as the "Administrative Agent" under the Credit Agreement and the other Loan Documents (including the Security Agreement).


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby transfer and assign to Assignee all of Assignor's right, title and interest in and to the Security Agreement, the Grant and the Trademarks.

Assignor makes no representations or warranties whatsoever, express or implied, or by operation of law, to Assignee in connection with this Assignment.


