THIS ASSIGNMENT is made the 10th day of February 2011

BETWEEN

- (1) **INEOS SILICAS LIMITED** a private company incorporated in England and located at Bank Quay, Warrington, Cheshire WA5 1AB, United Kingdom (hereinafter called "the **Assignor**"); and
- (2) **PQ SILICAS UK LIMITED** a private limited company incorporated in England and having a registered office at Bank Quay, 4 Liverpool Road, Warrington, Cheshire WA5 1AQ, United Kingdom (hereinafter called "the **Assignee**").

WHEREAS

- (A) The Assignor is the proprietor of the trade mark applications and registrations short particulars of which are set forth in the Schedule (hereinafter called "the **Trade Marks**")
- (B) The parties hereto have agreed that the Trade Marks and rights ancillary thereto should be transferred by the Assignor to the Assignee for the consideration hereinafter set forth.

NOW THIS ASSIGNMENT WITNESSETH AS FOLLOWS:

1. In consideration of the sum of £1 (one pound sterling) and other good and valuable consideration now paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges) the Assignor hereby assigns to the Assignee with full title guarantee all its right, title and interest in and to the Trade Marks (including any renewals and extensions that may be granted thereof) together with the goodwill attaching to and symbolised by the Trade Marks and together with all rights of action, remedies, powers and benefits relating to the Trade Marks belonging or accrued including the right to sue for damages or other remedies in respect of any infringement of such rights prior to the date hereof **TO HOLD** unto the Assignee absolutely.
2. The Assignor and the Assignee agree to execute any such further supplemental documentation as may reasonably be required by the Assignee in order to register the Assignee as proprietor of the Trade Marks at the respective local Trade Marks Offices around the world (hereinafter referred to as "the **Local Documents**").
3. Each of the Local Documents and this Assignment shall be regarded as one and the same instrument and in the event of any conflict between the terms of any of the Local Documents and this Assignment, the terms of this Assignment shall prevail.




