TRADEMARK ASSIGNMENT 2(U.S.)

This TRADEMARK ASSIGNMENT ("Trademark Assignment"), effective as of March 30, 2011 ("Effective Date"), is made by and between Rock & Republic Enterprises, Inc., a California corporation ("Assignor"), and R&R Apparel Company, LLC, a Delaware corporation ("Assignee").

WHEREAS, VF Corporation, on the one hand, and Rock & Republic Enterprises, Inc., Triple R, Inc., Rock Holdings, Inc., Global Domination Enterprises, Inc., Brick & Mortar, Inc. and Michael Ball, on the other hand, have entered into that certain Asset Purchase Agreement, dated as of December 20, 2010 (the "Asset Purchase Agreement");

WHEREAS, pursuant to the Asset Purchase Agreement, Assignor sold, transferred, assigned, conveyed and delivered to VF Corporation all of Assignor's rights, title and interest in, to and under Assignor's trademarks, trademark applications, service marks, design marks, trade names, service names, brand names, trade dress rights, logos, slogans, signs, insignias, and other brand or source identifiers, including those that are the subjects of registrations and pending applications, as set forth on Attachment 1 hereto (the "Assigned Marks");

WHEREAS, Assignee is a subsidiary of VF Corporation created to receive the Assigned Marks; and

WHEREAS, Assignor and Assignee wish to confirm such assignment and have such assignment recorded with the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor hereby sells, transfers, assigns, conveys and delivers to Assignee all of Assignor's right, title and interest in and to the Assigned Marks, including all claims for past infringement thereof and all income, royalties, damages and payments now or hereafter due or payable with respect thereto. Assignor's business to which the Assigned Marks pertain is not or will not be ongoing and existing.
2. Filing. Assignor hereby authorizes and requests the United States Patent and Trademark Office to record Assignee as the owner of Assignor's entire right, title and interest in and to the Assigned Marks.
3. Invalidity. It is understood that any finding of invalidity of one assignment as effected hereby shall not affect the assignment of the other Assigned Marks.
4. Other Actions. Upon reasonable request by Assignee, and at Assignor's sole cost and expense, Assignor (or its designated trustee or agent) will

execute additional documents and take other actions as may be necessary or desirable to record or memorialize the assignment of the Assigned Marks set forth herein, and to vest in Assignee such right, title, and interest in and to the Assigned Marks as sold, assigned and transferred to Assignee hereunder.

5. Modifications. No waiver, modification or change of any of the provisions of this Assignment shall be valid unless in writing and signed by the party against whom such claimed waiver, modification or change is sought to be enforced.
6. Counterparts. This Trademark Assignment may be executed in any number of counterparts, and the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Trademark Assignment by facsimile or other electronic means (*e.g.*, electronic mail or PDF) shall be effective as delivery of a manually executed counterpart to this Trademark Assignment.
