**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of March 30, 2011 by **BANK OF AMERICA, N.A.**, as administrative agent, a national banking association (the "Administrative Agent") with a place of business at 185 Asylum Street, 35th Floor Hartford, CT 06115, in favor of Keystone Automotive Distributors Company, LLC, a corporation organized under the laws of the State of Delaware (the "Assignor").

WITNESSETH:

WHEREAS, Keystone Marketing Services, Inc. (predecessor-by-merger of the Assignor) entered into an agreement with the Administrative Agent which was recorded in the Trademark Division of the United States Patent and Trademark Office on November 28, 2003 at Reel 2870, Frame 0532 for the purpose of providing certain trademarks as collateral security for the payment and performance of certain obligations of Keystone Marketing Services, Inc. to the Administrative Agent; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Definitions. The term "Trademark Collateral", as used herein, shall mean all of the Assignor's right, title and interest of every kind and nature as of the date hereof in the Assignor's trademarks (including, without limitation, those items listed on Schedule A hereto, (each, a "Trademark")), together with any applications, reissues, continuations or extensions thereof, and Trademark Licenses and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its security interest in the Trademark Collateral, together with all products and proceeds thereof, including without limitation, any claims by Assignor against third parties for past, present or future (a) infringement, dilution or other violation of any Trademark, or (b) injury to the goodwill associated with any Trademark, without representation, warranty or recourse of any kind or nature (together with the Trademark Collateral, the "Trademark Rights").

3. Reassignment. The Administrative Agent hereby reassigns, grants and conveys to Assignor, without any representation, recourse or undertaking by the Administrative Agent, any and all of the Administrative Agent's right, title and interest in and to the Trademark Collateral and the Trademark Rights.
