RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of March 31, 2011 by JPMORGAN CHASE BANK, N.A., (the "Administrative Agent") to KENNETH COLE PRODUCTIONS (LIC), LLC, (the "Grantor"), as follows:

WHEREAS, on July 30, 2009, Kenneth Cole Productions, Inc. (the "Borrower"), the Grantor, certain other Subsidiaries of the Borrower and the Administrative Agent entered into a Pledge and Security Agreement ("Security Agreement");

WHEREAS, on July 30, 2009 and February 10, 2010, the Grantor and the Administrative Agent entered into a Confirmatory Grant of Security Interest in United States Trademarks (collectively the "Confirmatory Grant");

WHEREAS, pursuant to said Security Agreement and Confirmatory Grant, the Grantor granted to the Administrative Agent on behalf of the Lenders, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Marks");

WHEREAS, said Confirmatory Grant was recorded in the United States Patent & Trademark Office on August 3, 2009 at reel/frame 4035/923 and on March 8, 2010 at reel/frame 4162/541; and

WHEREAS, Administrative Agent wishes to release its security interest in the Marks.
