**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE, dated as of March 30, 2011, from Bank of America, N.A., successor to LaSalle Bank National Association, as the agent (in such capacity, the "*Agent*"), to AutomationSolutions, Inc., a Delaware corporation (the "*Grantor*").

WITNESSETH:

WHEREAS, in connection with that certain Amended and Restated Credit Agreement dated as of December 20, 2007, which amended and restated that certain Credit Agreement dated as of June 12, 2007 (as amended, amended and restated, restated, supplemented or otherwise modified from time to time), by and among the Grantor, the financial institutions from time to time party thereto and the Agent, the Grantor executed and delivered to the Agent a Trademark Security Agreement, dated June 12, 2007 (the "*TSA*"), which TSA was filed with the United States Patent and Trademark Office on June 20, 2007 under Reel 3564, Frame 0624;

WHEREAS, pursuant to the TSA and the Security Agreement, dated June 12, 2007 (as amended, amended and restated, restated, supplemented or otherwise modified from time to time, the "*Security Agreement*"), made by the Grantor and AutomationSolutions Holding Company, a Delaware corporation, in favor of the Agent, the Grantor granted a security interest (the "*Security Interest*") to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined); and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby. The Agent authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.


