RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this "Release"), dated as of March 31, 2011, is made by Madison Capital Funding LLC, as administrative agent for the Lenders (as defined in the Trademark Security Agreement defined below) (the "Agent").

WHEREAS, Pretium Packaging, L.L.C., a Delaware limited liability company (the "Grantor") and the Agent entered into a certain Trademark Security Agreement, dated as of February 16, 2010 made by the Grantor in favor of the Agent (as may be amended, modified, restated or supplemented from time to time, the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted a security interest in certain trademarks owned by the Grantor, including those set forth on Schedule I attached hereto (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office at Reel 4155, Frame 27; and


WHEREAS, the Grantor wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby irrevocably releases, without representation, recourse or warranty whatsoever all of its right, title and interest in the Trademark Collateral, whether granted pursuant to the Trademark Security Agreement or any other agreement or document delivered in connection with the Trademark Security Agreement, and the Agent hereby reassigns to the Grantor any and all such right, title and interest (if any) that the Agent may have in the Trademark Collateral.

The Agent agrees to execute and deliver to the Grantor, at the Grantor's sole cost and expense, any further documents or instruments and perform further acts which the Grantor (or Grantor's agents or designees) reasonably request in order to confirm this Release and the Grantor's right, title and interest to the Trademark Collateral.
