**NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARK**

WHEREAS, pursuant to that certain Trademark Security Agreement dated June 27, 2008 (the "Security Agreement"), recorded in the United States Patent and Trademark Office on July 1, 2008 at Reel 3807, Frame 0412, New Poseidon Enterprises, LLC and Bright Water Seafoods, LLC, Delaware limited liability companies ("Grantors"), assigned to and granted to Regions Bank, an Alabama Banking Corporation ("Grantee"), a security interest in all right, title and interest of Grantors in and to the trademark listed on the attached "Exhibit A" ("Trademark") and Trademark Registration No. 2,510,491 for such Trademark ("Registration"); and
