NOTICE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF SECURITY INTEREST IN TRADEMARKS dated as of March 31, 2011 is by and between FOTOFAB, LLC, a Delaware limited liability company ("Fotofab"), and ALDINE SBIC FUND, L.P., a Delaware limited partnership (the "Lender").

The parties acknowledge the following:

A. Fotofab, Elcon Precision, LLC, a Delaware limited liability company ("Elcon"), PRE Diversified Holdings, LLC, a Delaware limited liability company and the sole member of both Fotofab and Elcon ("Holdings"), and the Lender are parties pursuant to that certain Subordinated Pledge and Security Agreement dated as of March 31, 2011 (the "Security Agreement").

B. Fotofab owns the Trademarks (the "Trademarks") listed on Exhibit A attached hereto, which Trademarks are registered with or applications therefore are pending before the United States Patent and Trademark Office.

C. Pursuant to the Security Agreement, Fotofab has granted to the Lender a security interest in and to (i) all of the Trademarks, (ii) all renewals and extensions thereof, (iii) all income, royalties, damages and payments now or hereafter due and/or payable under and with respect thereto, including without limitations payments under all licenses entered into connection therewith and damages and payments for past or future infringements thereof, (iv) the right to sue for past, present and future infringements thereof and (v) trademarks, trademark registrations and trademark applications and any other rights corresponding thereto throughout the world.

D. Fotofab hereby confirms and reaffirms its grant to the Lender of a security interest in the Trademarks and other collateral described in paragraph C, and does hereby grant to the Lender a security interest in the Trademarks and other Collateral described in paragraph C to secure the prompt payment and performance of the Secured Obligations (as defined in the Security Agreement).


