**ASSIGNMENT OF TRADEMARKS**

This **ASSIGNMENT OF TRADEMARKS** (the "Assignment") is entered into as of the date of last signature by and between Covanta ARC Company (a Delaware partnership between Covanta Ref-Fuel Management II, LLC and Covanta Ref-Fuel Management, LLC), with its principal place of business at 445 South Street, Morristown, New Jersey 07960 (the "Assignor"), and Covanta Energy Corporation, a Delaware corporation with its principal place of business at 445 South Street, Morristown, New Jersey 07960 ("Assignee").

**WHEREAS**, Assignor owns rights in the trademark REF-FUEL, including U.S. Reg. No. 1,602,911 (the "Mark");

**WHEREAS**, Assignee desires to acquire all right, title and interest in and to the Mark, throughout the world, together with the goodwill of the business symbolized by the Mark from Assignor; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns to Assignee, and Assignee hereby accepts from Assignor, all right, title, and interest in and to the Mark throughout the world together with the goodwill of the business symbolized by the Mark, including, but not limited to, all common law rights and trademark applications and registrations therefor. Assignor further sells, assigns, transfers and sets over to Assignee the right to apply for trademark registrations and domain name registrations and to sue and collect and retain damages and/or profits for past, present and future infringements of the Mark.

2. At any time, and from time to time after the date hereof, at Assignee's request, Assignor shall execute and deliver such other instruments of sale, transfer, conveyance, assignment and confirmation and take such other action at Assignee's expense as Assignee may reasonably deem necessary or desirable in order to more effectively transfer, convey and assign to Assignee and to confirm Assignee's title to the Mark and any and all trademark applications and registrations therefor, and to assist Assignee in exercising all rights with respect thereto.

3. This Assignment shall be binding upon the parties, their successors, heirs, assigns, legal representatives and all others acting by, through, with or under their direction, and all those in privity therewith. Assignee shall record this Assignment of Trademarks with the United States Patent and Trademark Office.
