PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST

This Partial Release of Trademark Security Interest (this "Partial Release") is given on this 31st day of March 2011 by JPMorgan Chase Bank, National Association, as Administrative Agent, (the "Administrative Agent"), to Friendship Dairies, LLC (the "Debtor"), a Delaware limited company (the "Debtor"), as follows:


WHEREAS, said Security Agreement was recorded in the United States Patent & Trademark Office on August 21, 2009 at reel/frame 4050/176; and
