3 Representations and Warranties


The Assignor does not make, nor shall be deemed to have made, to the Assignee any express or implied representation or warranty with respect to any of the Trade Marks.

4 Law and Jurisdiction


- 4.1 This Deed and any non-contractual obligations arising out of it shall be governed by and construed in accordance with English law.


