(2) the right to apply for, prosecute and obtain trademark registrations worldwide, or similar rights of protection, for the Trademarks and the goodwill associated with the Trademarks, including the right to claim priority from any application relating to the Trademarks.

Assignor agrees that Assignee may record this Trademark Assignment Agreement in any trademark office worldwide, where it will be open for public inspection. This Assignment is subject to and with the benefit of the "Stock Purchase Agreement" dated September 30, 2010, entered into between Assignor and Assignee, and receipt and sufficiency of good and valuable consideration is hereby acknowledged by Assignor.

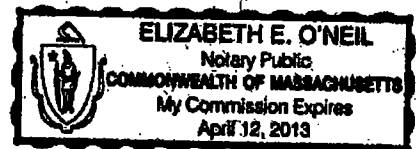
