



The undersigned, Kinder Morgan, Inc., a Kansas corporation (the "Corporation"), for the purpose of amending the Amended and Restated Articles of Incorporation of the Corporation (the "Amended and Restated Articles of Incorporation"), in accordance with the General Corporation Code of the State of Kansas, does hereby make and execute this Certificate of Amendment to the Amended and Restated Articles of Incorporation (this "Certificate of Amendment") and does hereby certify that:

1. The name of the Corporation is "Kinder Morgan, Inc." Kinder Morgan, Inc. was originally incorporated under the name Kansas Pipe Line & Gas Company and the original Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Kansas on May 18, 1927. 
