**AGREEMENT OF TRANSFER AND ASSIGNMENT
OF TRADE MARKS**

DATE: 14 December 2007

PARTIES:

- (1) **Carglass Luxembourg S.à.r.l - Zug branch** of Gotthardstrasse 20, CH-6304 Zug, Switzerland (formerly of Aegeristrasse 33, CH-6300 Zug, Switzerland) registered in Switzerland under the laws of Switzerland ("**CLS-Zug**"), a branch of Carglass Luxembourg S.à.r.l (Party (2))
- (2) **Carglass Luxembourg S.à.r.l** of 9B boulevard Prince Henri, L-1724 Luxembourg (formerly of 16 route de Longwy, L-8080 Bertrange, Luxembourg) a company organized and existing under the laws of Luxembourg ("**CLS**")
- (3) **Belron Hungary Kft** of Várkonyi utca 15., Szombathely 9700, Hungary, a company organized and existing under the laws of Hungary ("**BH**")
- (4) **Belron Hungary Kft – Zug branch** of Gotthardstrasse 20, CH-6304 Zug, Switzerland registered in Switzerland under the laws of Switzerland ("**BH-Zug**"), a branch of Belron Hungary Kft (Party 3)

RECITALS:

- A. **CLS-Zug** is the proprietor of the trade marks particularized in Schedule 1 attached to this Agreement ("**TRADE MARKS**"), in a number of cases by virtue of a Shareholders' Resolution of **CLS** of 25th March 1999 and individual national confirmatory transfer documents signed by **CLS**
- B. By a Circular Resolution of the Board of Managers of **CLS** on the 14_December 2007 (the "**TRANSFER DATE**") the **TRADE MARKS** have been transferred to **CLS** and the parties have agreed to execute this Agreement pursuant to the said Resolution for the purpose of confirming legal title of the **TRADE MARKS** in **CLS**
- C. **CLS** has incorporated **BH** and by an Agreement for the Transfer of Assets **CLS** on the **TRANSFER DATE** assigned its rights in the **TRADE MARKS** to **BH** and the parties have agreed to execute this Agreement pursuant to

the said Agreement for the Transfer of Assets and Liabilities for the purpose of confirming legal title in **BH**

- D. By a Resolution taken by the Managing Directors of **BH** on the **TRANSFER DATE** the **TRADE MARKS** have been transferred to **BH-Zug** and the parties have agreed to execute this Agreement pursuant to the said Resolution for the purpose of confirming legal title of the **TRADE MARKS** in **BH-Zug**

OPERATIVE TERMS:

1. Transfers

- 1.1 **CLS-Zug** (Transferor 1) hereby transfers and confirms the transfer to **CLS** on the **TRANSFER DATE** and **CLS** (Transferee 1) hereby accepts and confirms its acceptance of the **TRADE MARK RIGHTS** as defined below.
- 1.2 **CLS** (Transferor 2) hereby transfers and confirms the transfer to **BH** on the **TRANSFER DATE** (effective immediately after the transfer referred to in clause 1.1) and **BH** (Transferee 2) hereby accepts and confirms its acceptance of the **TRADE MARK RIGHTS** as defined below.
- 1.3 **BH** (Transferor 3) hereby transfers and confirms the transfer to **BH-Zug** on the **TRANSFER DATE** (immediately after the transfer referred to in clause 1.2) and **BH-Zug** (Transferee 3) hereby accepts and confirms its acceptance of the **TRADE MARK RIGHTS** as defined below.
- 1.4 For the purposes of this Agreement the **TRADE MARK RIGHTS** means all the property right title and interest in and to the **TRADE MARKS** including the goodwill relating to the **TRADE MARKS** and all common law rights in relation to the **TRADE MARKS** and all rights to sue for and obtain injunctive relief, damages and all other relief in respect of any infringement or misuse of or passing off in relation to any of the same, whether past, present or future and all rights to rely upon any of the **TRADE MARKS** in opposition or other proceedings including the right to take over as the opponent or complainant in any existing proceedings.

- 1.5 For the purposes of this Agreement, the expression "Transferors" shall mean Transferor 1, Transferor 2 and Transferor 3 and each of them and the expression "Transferee" shall mean Transferee 1, Transferee 2 or Transferee 3 as the context requires.

2. Further Assurance and Authorization

The Transferors agree to execute any further documents and do all things which are deemed necessary in order to vest in the relevant Transferee (or its successor in title or nominee as the case may be) the TRADE MARKS and all other property rights title and interests intended to be transferred or granted to the relevant Transferee hereunder and to give the relevant Transferee the full benefit of this Agreement including doing all acts which may be necessary or desirable to record the relevant Transferee as proprietor of the TRADE MARKS. The Transferors hereby authorize each Transferee and the agents of each Transferee to sign all such forms as the relevant Transferee considers appropriate in order to record the relevant Transferee as proprietor of the TRADE MARKS.

3. Law and Jurisdiction

This Agreement shall be governed by and interpreted in accordance with the laws of Hungary and the parties hereby agree that all actions or proceedings arising hereunder or in connection with this Agreement shall be brought in the first instance before the competent court in Hungary.

IN WITNESS of which the parties have executed this Agreement, in multiple originals, on the date shown at the beginning in accordance with their statutes by duly authorized officers

This Transfer and Assignment may be executed in any number of counterparts and all of such counterparts taken together shall be deemed to constitute one and the same instrument.
