

AND, BCI HEREBY authorizes UNITEK GLOBAL SERVICES, INC., its successors, legal representatives and assigns, to file affidavits, renewals and other such papers and documents needed to keep the Mark in force;

AND BCI HEREBY covenants that we have full rights to convey the entire right, title and interest herein assigned, and that we have not executed and will not execute, any agreement in conflict herewith;


