RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of April 11, 2011 in favor of Grande Communications Networks LLC (the "**Grantor**") by Société Générale, as Collateral Agent (the "**Collateral Agent**").

RECITALS

- A.** The Grantor has heretofore granted to the Collateral Agent a lien on and security interest in all of its right, title and interest in and to Grantor's trademarks, trademark registrations and trademark applications, including but not limited to those trademarks, trademark registrations and trademark applications set forth on Schedule A hereto, to secure the Secured Obligations (as defined in that certain Pledge and Security Agreement among the Grantor, Grande Parent LLC, the other grantors from time to time party thereto and the Collateral Agent, dated September 14, 2009, as amended, modified, restated and/or supplemented (the "**Pledge and Security Agreement**")).
- B.** Pursuant to the Pledge and Security Agreement, the Grantor executed an intellectual property security agreement (the "**IP Security Agreement**"), in which the Grantor granted to the Collateral Agent a lien on and security interest in all of its right, title and interest in, to an under certain intellectual property, including those trademarks set forth on Schedule A hereto (the "**Trademarks**").
- C.** The Collateral Agent recorded the IP Security Agreement with the United States Patent and Trademark Office on September 15, 2009, a Reel 4061, Frame 0886 for the purpose of recording its security interest in and lien on the Trademarks.
- D.** The Collateral Agent now wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to dissolve any and all liens and encumbrances respecting the Trademarks.

SECTION 1 Defined Terms

Unless otherwise defined herein, terms defined in the Pledge and Security Agreement and used herein have the meaning given to them in the Pledge and Security Agreement.

SECTION 2 Release

For good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby, on behalf of itself and the Secured Parties (as defined in the Pledge and Security Agreement), (i) terminates the (x) Pledge and Security Agreement and (y) IP Security Agreement, (ii) terminates, cancels and releases any and all liens and security interests it has in, to and under the Trademarks, (iii) re-assigns to the Grantor any right, title and interest in may have in, to and under the Trademarks, and (iv) authorizes and requests that the United States Patent and Trademark Office, and any other location where the security interest was filed, note and record the existence of such release hereby given.

SECTION 3 Governing Law

THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER ARE GOVERNED BY, AND WILL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE INTERNAL LAWS OF THE STATE OF NEW YORK (INCLUDING SECTION 5-1401 OF THE




