TRADEMARK ASSIGNMENT

WHEREAS, DOLFIN INTERNATIONAL CORPORATION, a corporation organized and existing under the laws of the Commonwealth of Pennsylvania, having an address at 4 Front Street Plaza, 34 West Wyomissing Avenue, Mohnton, Pennsylvania 19540 (hereinafter "DOLFIN"), is the owner of all rights, title and interest in and to the United States trademarks and trademark registrations and applications as identified in Exhibit A, attached, (all of said United States trademarks and trademark registrations and applications; hereinafter being collectively referred to as "Trademark Rights") and in and to the goodwill of the business associated with the use of, and symbolized by, the Trademark Rights;

WHEREAS, PHANTOM INDUSTRIES, INC., a corporation organized and existing under the laws of the Province of Ontario, and having an address at 207 Weston Road, Toronto, Ontario, Canada M6N 4Z3 (hereinafter "PHANTOM"), is desirous of acquiring all of the rights, title and interest in and to the Trademark Rights and in and to the goodwill of the business associated with the use of, and symbolized by, the Trademark Rights;

WHEREAS, DOLFIN and PHANTOM are parties to an ASSET PURCHASE AGREEMENT dated August 1, 2008 ("the Agreement");

WHEREAS, pursuant to the Agreement DOLFIN agreed to sell and did sell, and PHANTOM agreed to purchase and did purchase the Assets identified in Section 2.1 of the Agreement, including, but not limited to, the Intellectual Property specified in Section 2.1 and identified in Exhibit A ("Purchased Assets") of the Agreement and the

Trademark Rights and the goodwill of the business associated with the use of, and symbolized by, the Trademark Rights; and

WHEREAS, DOLFIN and PHANTOM desire to memorialize the transfer of the Trademark Rights and the goodwill associated therewith pursuant to the Agreement in a form suitable for recordation.

NOW, THEREFORE, DOLFIN and PHANTOM, intending to be legally bound under the laws of the Commonwealth of Pennsylvania, and for good and valuable consideration as set forth in the Agreement, the receipt and sufficiency of which is hereby acknowledged, agree as follows:

1. DOLFIN hereby confirms its agreement to sell, confirms that it sold and does hereby sell to PHANTOM, and PHANTOM hereby confirms its agreement to purchase, confirms that it purchased and does hereby purchase from DOLFIN, all of the rights, title and interest in and to the Trademark Rights and in and to the goodwill of the business associated with the use of, and symbolized by, the Trademark Rights, including the right to sue others for past acts of infringement of the Trademark Rights and to retain all revenues received from others for past acts of infringement of the Trademark Rights.

2. DOLFIN further agrees for itself, successors, assigns, and its legally bound predecessors to execute, without further consideration, any further legal documents, any further assignments, and any releases, declarations, renewals or other applications for Trademark Rights that may be deemed necessary by PHANTOM, or by PHANTOM's successors-in-interest or assigns, fully to secure to PHANTOM, or to PHANTOM's successors-in-interest or assigns, DOLFIN's interest as aforesaid in and to

the Trademark Rights and in and to the goodwill of the business associated with the use of, and symbolized by, the Trademark Rights.
