RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST made and entered into this 15th day of November, 2006, by MANUFACTURERS AND TRADERS TRUST COMPANY, a New York banking corporation ("Assignor"), as Trustee and collateral agent for Holders, as defined in the Security Agreement referenced below, in favor of RENT-WAY, INC., a Pennsylvania corporation ("Assignee").
