**RELEASE OF SECURITY INTEREST**

THIS RELEASE OF SECURITY INTEREST made and entered into this 15<sup>th</sup> day of November, 2006, by NATIONAL CITY BANK OF PENNSYLVANIA ("Assignor"), as Administrative Agent for the Banks as defined in the Credit Agreement referenced below, in favor of RENT-WAY OF MICHIGAN, a Delaware corporation ("Assignee").

WHEREAS, Assignor now desires to release and terminate the Security Agreement;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases to Assignee all interest which Assignor and/or the Banks possess or are otherwise entitled to in the aforementioned property, including but not limited to the trademarks and registrations listed in Schedule I hereto by virtue of such Security Agreement or Credit Agreement.
