**ASSIGNMENT OF TRADEMARKS AND PATENTS**

The Assignor further grants to the Assignee the right to sue and recover damages (and obtain all other relief) for any infringements of the Trademarks that have occurred prior to the date of this Assignment, for Assignee's own use and enjoyment and for the use and enjoyment of its successors or assigns, free and clear of all liens, claims, security interests, and other encumbrances.

Assignor agrees to execute all documents and assist in all proceedings (at the sole cost and expense of the Assignee) to perfect, register, or record the rights of the Assignee to the Trademarks as Assignee may reasonably deem appropriate. If Assignor does not, within fifteen (15) days of presentment, return the requested executed documents, then Assignee is hereby granted a limited power of attorney to execute all such documents on behalf of Assignor. This power of attorney is coupled with an interest and is irrevocable.
