ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment of Intellectual Property (this "Assignment Agreement") is made and entered into as of November 26, 2008 by and between j2 Global Communications, Inc., a Delaware corporation ("Buyer"), and Mijanda Inc., a Delaware corporation (the "Company" or "Seller").

Recitals

A. Seller and Buyer are parties to that certain Asset Purchase Agreement dated as of November 26, 2008 (the "Purchase Agreement") under which Seller has agreed, among other things, to sell, assign, transfer and deliver to Buyer, free and clear of all Liens (other than the Permitted Liens) the Purchased Assets. Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Purchase Agreement.

B. The execution and delivery of this Assignment Agreement by Seller and Buyer is a requirement under the Purchase Agreement.

THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Seller hereby sells, assigns, and transfers to Buyer, free and clear of all Liens (other than the Permitted Liens) all of Seller's Intellectual Property, and rights attached thereto, including, without limitation, the Intellectual Property listed on Schedule A.
2. This Assignment Agreement shall be binding upon, inure to the benefit of, and be enforceable by Buyer and its successors and assigns.
3. Seller, for itself and its successors and assigns, by this Assignment Agreement, covenants with the Buyer and its successors and assigns, that Seller and its successors and assigns will do, execute and deliver and will cause to be done, executed and delivered all such further acts, transfers, assignments and conveyances, powers of attorney and assurances, for better assuring, conveying and confirming unto the Buyer and its successors and assigns, all the Intellectual Property hereby conveyed, transferred and assigned as the Buyer and its successors and assigns, reasonably request, and the covenants and agreements herein conveyed shall inure to the benefit of the Buyer and its successors and assigns and shall bind and be enforceable against Seller and its successors and assigns.
4. This Assignment Agreement shall be governed by and construed in accordance with the laws of the State of Michigan without regard to its conflict of law rules.
