

SECOND LIEN TRADEMARK SECURITY AGREEMENT

SECOND LIEN TRADEMARK SECURITY AGREEMENT, dated as of the 28th day of March, 2011, by Quintiles Transnational Corp., a North Carolina corporation (the "Grantor"), in favor of Citicorp North America, Inc., in its capacity as collateral agent pursuant to the Credit Agreement (as defined in the Security Agreement, defined below), as pledgee, assignee and secured party (in such capacities and together with any successors in such capacities, the "Collateral Agent").

WHEREAS, the Grantor has, pursuant to that certain second lien security agreement dated as of March 31, 2006 (as supplemented from time to time, the "Security Agreement"; capitalized terms used but not defined herein having the meaning assigned to such term in the Security Agreement), granted to the Collateral Agent for the benefit of the Secured Parties a security interest in and to all of the right, title and interest of such Grantor, in, to and under the Collateral, including with respect thereto, the Trademarks, as collateral security for the payment and performance in full when due of the Secured Obligations; and

WHEREAS, the Grantor and the Collateral Agent wish to further memorialize the security interest described above as it relates to the Trademarks that are the subject of trademark registration applications that are pending with the US Patent and Trademark Office, identified in Schedule A, attached hereto, and incorporated herein by this reference, and the goodwill attendant thereto and all other rights appurtenant thereto, including but not limited to all products and proceeds thereof;

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Grantor hereby grants unto the Collateral Agent a security interest in and lien on all of its right, title and interest in the Trademarks identified in Schedule A, as collateral security for the payment and performance in full when due of the Secured Obligations.
