**TRADEMARK ASSIGNMENT**

This Trademark Assignment (this "Assignment") is dated March 23, 2011 and is between TIGER CLAW, INC., a Connecticut corporation ("Tiger Claw") and OMG, INC., a Delaware corporation ("OMG").

On March 23, 2011, Tiger Claw and OMG entered into an Asset Purchase Agreement (the "Purchase Agreement"), pursuant to which Tiger Claw agreed to assign to OMG all of Tiger Claw's title, rights and interest in and to the U.S. federal Trademark Registrations and the U.S. Intent to Use Applications, set forth on Schedule A (the "Marks"). Tiger Claw and OMG wish to document the formal assignment to OMG of all of Tiger Claw's title, interest and rights in and to the Marks and the goodwill associated therewith.

The parties, intending to be legally bound, agree as follows:

1. Tiger Claw does hereby sell, assign, transfer and set over to OMG Tiger Claw's entire right, title, and interest in and to the Marks together with the goodwill and the business in connection with which the Marks are used and which is symbolized by the Marks, and all registrations and applications therefore, in the United States of America, including any renewals and extensions of the registrations that are or may be secured under the laws of the United States of America, nor or hereafter in effect, for OMG's own use and enjoyment, and for the use and enjoyment of OMG's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Tiger Claw if this Assignment had not been made.
2. Tiger Claw requests the Commission of Patents and Trademarks of the United States of America to record OMG as the owner of the Marks, including any variations thereof, for the sole use and enjoyment of OMG, its successors, assigns or other legal representatives.
3. Tiger Claw agrees to execute upon the request of OMG any assignment paper or other document necessary to evidence the assignment of the rights hereunder to OMG. Tiger Claw agrees to cooperate with OMG in all other matters relating to the assignment of these rights to OMG.
