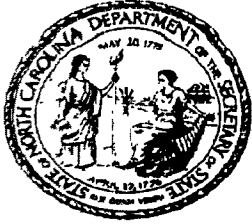

ARTICLES OF AMENDMENT
BUSINESS CORPORATION

Pursuant to §55-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation.

1. The name of the corporation is: Southeastern Oil Jobbers Cooperative, Inc.

WHEREAS, by resolution of the Board of Directors ("Board") on November 10, 2007, the Board recommends that the membership vote to change the name of the Southeastern Oil Jobbers Cooperative, Inc. ("SOJC", "Cooperative") to Pure Oil Jobbers Cooperative, Inc.; and

WHEREAS, the Board recommends this action because the SOJC name is less attractive and confusing to prospective Cooperative members outside the original ten states.

BE IT THEREFORE RESOLVED, that on a motion of the Board to change the name of the Southeastern Oil Jobbers Cooperative, Inc. to Pure Oil Jobbers Cooperative, Inc.
