RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of December 20, 2010 ("Effective Date") by and between Lingo Systems, LLC ("Grantor"), and Bank of America, N.A. and its successors, assigns and other legal representatives ("Grantee").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of November 4, 2009, as amended and modified by and between Grantor, Grantee, Language Line, LLC and Coto Acquisition LLC (now known as Tele-Interpreters Acquisition LLC) (the "Trademark Security Agreement"), Grantor pledged and granted to Grantee a continuing security interest in and lien on all of its right, title and interest in and to its Pledged Collateral (as defined in the Trademark Security Agreement), including without limitation the trademark registrations and applications set forth on Schedule A hereto (collectively, the "Trademark Collateral") together with the goodwill associated therewith;

WHEREAS, Grantor, certain of its affiliates and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Security Agreement, dated as of November 4, 2009;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") at Reel 4091, Frame 0273 on November 5, 2009; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests and liens it has against the Trademark Collateral together with the goodwill associated therewith.

If and to the extent Grantee has acquired any right, title or interest to any of the Trademark Collateral or the goodwill associated therewith, it hereby assigns and transfers such rights, title or interest to Grantor.

Grantee shall take all further actions, reasonably acceptable to Grantee, and provide to Grantor and each of its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor, each at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

IN WITNESS WHEREOF, Grantee has caused this Release to be executed by its duly authorized representative as of the Effective Date.
