Said **ASSIGNOR** hereby releases, assigns, and transfers unto said **ASSIGNEES** their successors, assigns and legal representatives, all rights, title, and interest, claims and demands whatsoever said **ASSIGNOR** had in, to and by, under and through, said trademarks, including all claims for any and all past infringement thereof and the right to sue therefor;

ALL OF THE SAME to be held and enjoyed by said ASSIGNEE for its own use and behoof and for its successors, assigns and legal representatives as fully and entirely as the same would have been held and enjoyed by said ASSIGNOR had this Assignment not been made.
