RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is made as of March 31, 2011 (“Effective Date”) by and between **Wells Fargo Bank, N.A.** (as successor by merger to **Wachovia Bank, National Association**), as administrative agent (in such capacity, the “Administrative Agent”), and **Radio One, Inc.**, a Delaware corporation (“Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Grantor and Administrative Agent dated as of June 13, 2005 (as amended, restated, supplemented otherwise modified from time to time, the “IP Security Agreement”), Grantor granted to Administrative Agent a continuing security interest in and to all of Grantor’s right, title and interest in and to the Intellectual Property Collateral (as defined in the IP Security Agreement), including, but not limited to, the trademark applications and registrations set forth on Schedule A attached hereto (the “Trademarks”), and the copyright registrations set forth on Schedule B attached hereto (the “Copyrights”);

WHEREAS, Grantor and Administrative Agent executed the IP Security Agreement pursuant to the terms and conditions of that certain Guarantee and Collateral Agreement by and between Grantor and Administrative Agent dated as of June 13, 2005 (as amended, restated, supplemented, replaced or otherwise modified from time to time, the “Guarantee and Collateral Agreement”);

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on July 13, 2005 at Reel/Frame 3120/0719;

WHEREAS, the IP Security Agreement was recorded with the United States Copyright Office on August 8, 2005 at Volume 3528, Document 278, Pages 1-5; and

WHEREAS, the Administrative Agent has agreed to terminate the IP Security Agreement as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby terminates the IP Security Agreement and the Guarantee and Collateral Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral.


Administrative Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Intellectual Property Collateral; (iii) it has not recorded or otherwise evidenced its security interest with respect to any of Grantor’s trademark registrations, trademark applications, trade names, assumed names, or copyright registrations, other than those Trademarks and Copyrights set forth on Schedules A and B attached hereto, in any jurisdiction throughout the world.

Administrative Agent shall, at the expense of Grantor, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
