RELEASE OF TRADEMARK SECURITY INTEREST, dated as of April 19, 2011 (this "Release"), by JPMORGAN CHASE BANK, N.A., as Administrative Agent and Collateral Agent (each as defined below). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement (each as defined below), as applicable.

Reference is made to (i) the Credit Agreement dated as of June 24, 2005, as amended by Amendment No. 1 dated as of March 24, 2006 (as further amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Tire Rack Holdings, Inc. ("Holdings"), The Tire Rack, Inc. (as successor-in-interest to Tread Merger Corporation, the "Borrower"), the Lenders from time to time party thereto and JPMorgan Chase Bank, N.A., as administrative agent (in such capacities, the "Administrative Agent"), (ii) the Guarantee and Collateral Agreement dated as of June 24, 2005 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Holdings, the Borrower, the Subsidiaries of the Borrower identified therein and JPMorgan Chase Bank, N.A., as collateral agent (in such capacity, the "Collateral Agent") and (iii) the Trademark Security Agreement dated as of June 24, 2005, as amended as of June 26, 2006 (as further amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), among Holdings, the Borrower and the Administrative Agent.

WHEREAS, pursuant to the Credit Agreement, the Security Agreement and the Trademark Security Agreement, the Grantors (as listed on Schedule I hereto) granted a security interest to the Administrative Agent and the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the trademarks of the Grantors set forth on Schedule II hereto, which security interest was recorded with the United States Patent & Trademark Office on (a) June 28, 2005, at Reel/Frame 003112/0209 and (b) July 17, 2006, at Reel/Frame 003349/0817; and

WHEREAS, in connection with the Termination and Release Agreement dated as of April 19, 2011, among Holdings, the Borrower, the Administrative Agent and the Collateral Agent (the "Termination and Release Agreement"), the Administrative Agent and the Collateral Agent now desire to terminate and release the entirety of their Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral (as defined below) pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent and the Collateral Agent hereby state as follows:

1. Definitions. The term "Trademark Collateral", as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks, including those listed on Schedule II hereto. The term "Trademarks" shall have the meaning set forth in the Security Agreement.

2. Release of Security Interest. The Administrative Agent and the Collateral Agent hereby terminate, release and discharge their respective security interests in the Trademark Collateral, and any right, title or interest of the Administrative Agent and the Collateral Agent in such Trademark Collateral shall hereby cease and become void.


3. Further Assurances. Each of the Administrative Agent and the Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
