RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is given as of this 18th day of April, 2011, by CREDIT SUISSE, CAYMAN ISLANDS BRANCH, a Swiss Bank, located at Eleven Madison Avenue, New York, New York 10010, as collateral agent for the Secured Parties ("Assignor"), in favor of DOUGLAS DYNAMICS, INC., a Delaware corporation, located at 7777 North 73rd Street, Milwaukee, WI 53223, DOUGLAS DYNAMICS, L.L.C., a Delaware limited liability company, located at 7777 North 73rd Street, Milwaukee, WI 53223, DOUGLAS DYNAMICS FINANCE COMPANY, a Delaware corporation, located at 7777 North 73rd Street, Milwaukee, WI 53223, and FISHER, LLC, a Delaware limited liability company, located at 50 Gordon Drive, Rockland, ME 04841, whether as an original signatory hereto or as an Additional Grantor (each an "Assignee" and collectively, the "Assignees").

Capitalized terms used in this Release, but not defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement or Security Agreement, as applicable.

WHEREAS, each Assignee is a party to a Term Pledge and Security Agreement, dated as of May 21, 2007 (the "Security Agreement"), in favor of Assignor pursuant to which each Assignee was required to execute and deliver a Trademark Security Agreement;

WHEREAS, each Assignee entered into that certain Trademark Security Agreement, dated as of May 21, 2007, in favor of Assignor;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 23, 2007, at Reel 3586/Frame 0963;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Assignee granted to Assignor for its benefit and for the benefit of the other Secured Parties, a security interest in and continuing lien on all of such Assignee's right, title and interest in, to and under all personal property of such Assignee including, but not limited to the following, in each case whether now owned or existing or hereafter acquired or arising and wherever located (all of which being hereinafter collectively referred to as the "Trademark Collateral"):

- (a) Trademarks of Grantor listed on Schedule I attached hereto;
- (b) all goodwill connected with the use of and symbolized by the foregoing; and
- (c) all Proceeds of any and all of the foregoing.

Notwithstanding anything herein to the contrary, in no event did the security interest granted attach to any lease, license, contract, property rights or agreement to which any Assignee was a party or any of its rights or interests thereunder if

and for so long as the grant of such security interest shall constitute or result in (a) the abandonment, invalidation or unenforceability of any right, title or interest of any Assignee therein or (b) in a breach or termination pursuant to the terms of, or a default under, any such lease, license, contract property rights or agreement (other than to the extent that any such term would be rendered ineffective pursuant to Sections 9-406, 9-407, 9-408 or 9-409 of the UCC (or any successor provision or provisions) of any relevant jurisdiction or any other applicable law (including the Bankruptcy Code) or principles of equity), provided however that, in the case of either (a) or (b) above, such security interest shall attach immediately at such time as the condition causing such abandonment, invalidation or unenforceability shall be remedied and to the extent severable, shall attach immediately to any portion of such Lease, license, contract, property rights or agreement that does not result in any of the consequences specified in (a) or (b) above.

WHEREAS, the Assignor and Assignee desire that Assignor terminate and release its security interest in all of Assignee's right, title and interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby releases and discharges its security interest in all of Assignee's right, title and interest in and to the Trademark Collateral, including but not limited to the Trademarks listed on Schedule I annexed hereto, and reassigns and transfers any and all interest that Assignor may have in the Trademark Collateral to Assignee.

Assignor hereby authorizes Assignee or Assignee's authorized representative to (i) file this Release with the United States Patent and Trademark Office, (ii) file Form UCC-3 Termination Statements or such other forms as may be necessary or appropriate to implement the Order and the Plan to memorialize the release of any security interest of Assignor in the Trademark Collateral, and/or (iii) otherwise file this Release in the applicable governmental office or agency.
