The Assignor grants the firm of **STEPTOE & JOHSON LLP** Washington DC, the power to insert on this Assignment any further identification which may be necessary or desirable to comply with the rules of the U.S. Patent and Trademark Office for recording of this document.

This Assignment is effective as of the 15th September of 2009.


