**TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (this "**Agreement**") is entered into between:

**TECHNICOLOR, previously named Thomson**, Société Anonyme, duly organized and existing under the laws of France, registered under the number 333 773 174 with the Commercial and Companies Registry of Nanterre and having its principal office at 1, Rue Jeanne d'Arc, 92443 Issy les Moulineaux, France, hereinafter referred to as "**Technicolor**",

On one part,

**TECHNICOLOR USA INC., previously named THOMSON INC.**, duly organized and existing under the laws of United States of America, having its principal office at 10330 North Meridian Street, Indianapolis, IN 46290, United States of America

On the other part,

Technicolor and Technicolor USA Inc., collectively, hereinafter referred to as "**Assignor**",

And

**GVBB HOLDINGS S.A.R.L.**, a company duly incorporated and existing under the laws of the Grand-Duché de Luxembourg and having a principal place of business at 412 F, route d'Esch, L-2086 Luxembourg, hereinafter referred to as "**Assignee**".

Assignor and Assignee are sometimes referred to in this Agreement collectively as the "**Parties**" or individually as a "**Party**".

**RECITALS**

WHEREAS Assignor is the owner of certain Trademarks (defined below) related to the Grass Valley Broadcast Business (defined below);

WHEREAS, Technicolor and certain affiliates of Technicolor, on the one hand, and Assignee, on the other hand, have separately signed an "Agreement for the Sale and Purchase of Grass Valley Broadcast Business" (the "**SPA**");

WHEREAS, in connection with the SPA, Assignor has agreed to assign to Assignee all its right, title, and interest in and to the Grass Valley Trademarks (defined below);

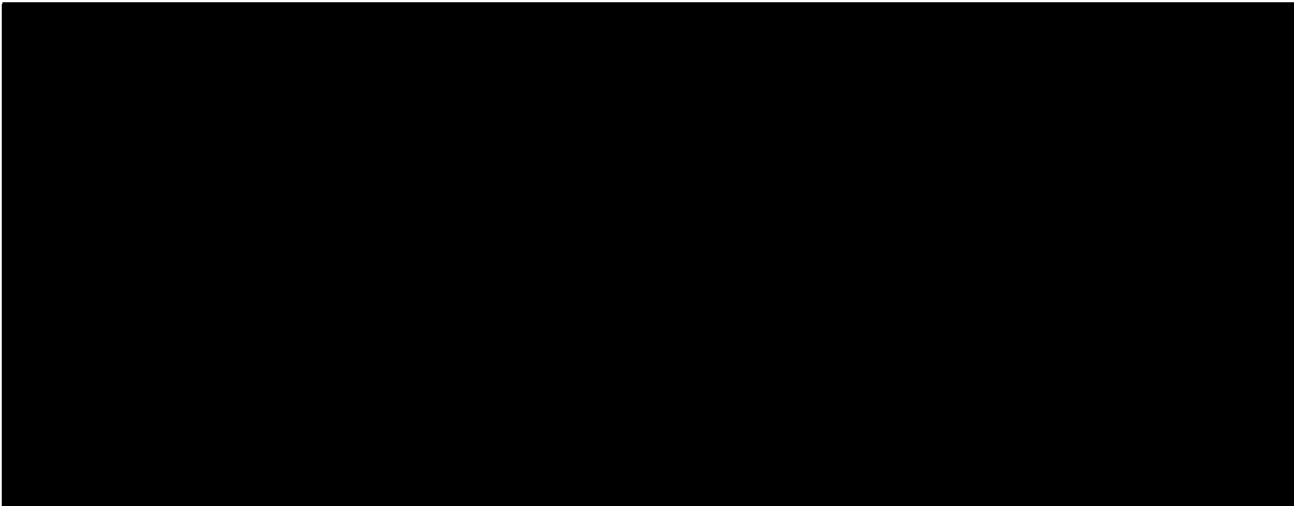
WHEREAS, Assignee has agreed to accept assignment of the Grass Valley Trademarks; and

WHEREAS the Parties now wish to confirm the terms and conditions of Assignee's acquisition of the Grass Valley Trademarks;

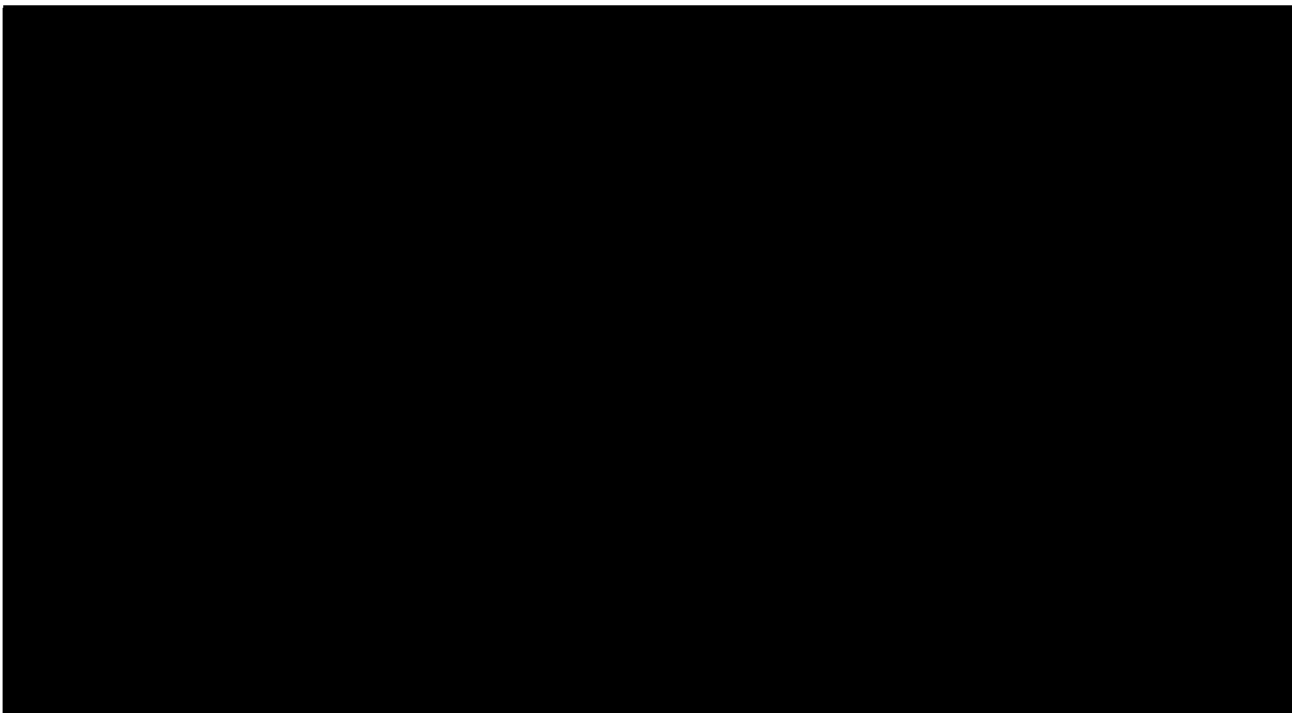
NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

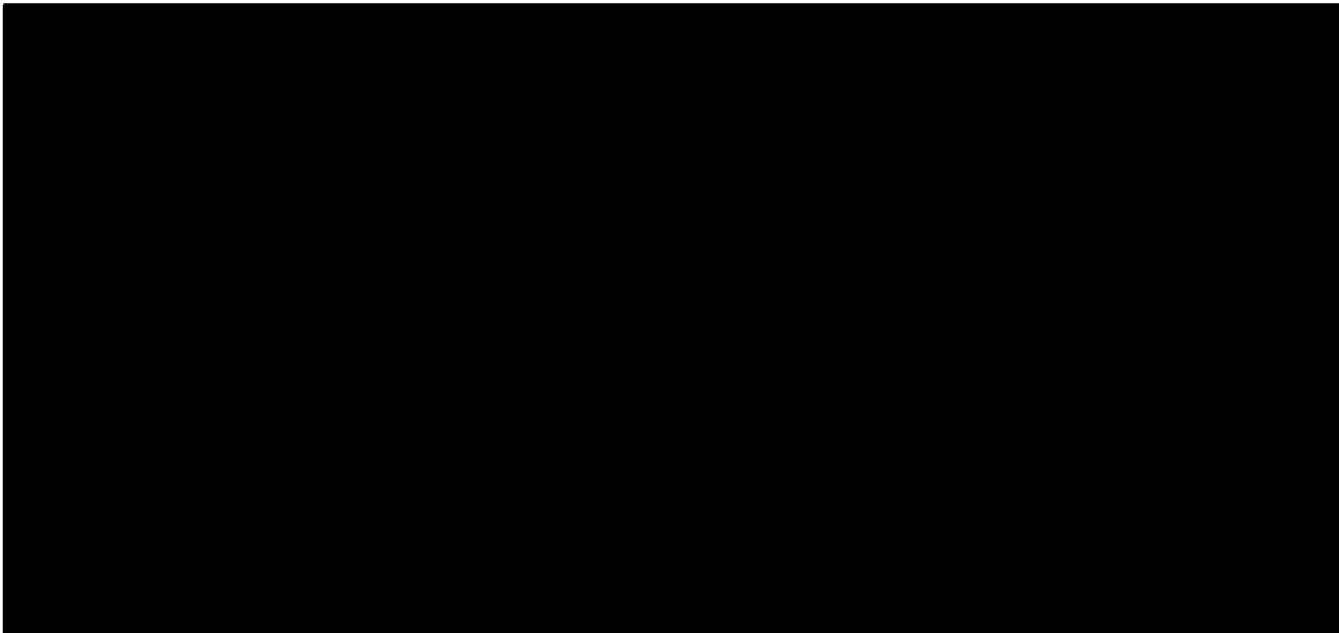
**1. DEFINITIONS**

As used in this Agreement, any capitalized terms shall have the meanings set forth below:



“Grass Valley Trademarks” means (i) all Trademarks that are owned by Technicolor’s Affiliates on the Effective Date and are primarily related to the Grass Valley Broadcast Business, including, without limitation, the Trademarks set forth in Exhibit 1 and Exhibit 2, and (ii) all rights and causes of action and remedies related thereto (including, without limitation, the right to sue and recover damages and other relief for past, present or future infringement, misappropriation or violation of rights related to the foregoing).

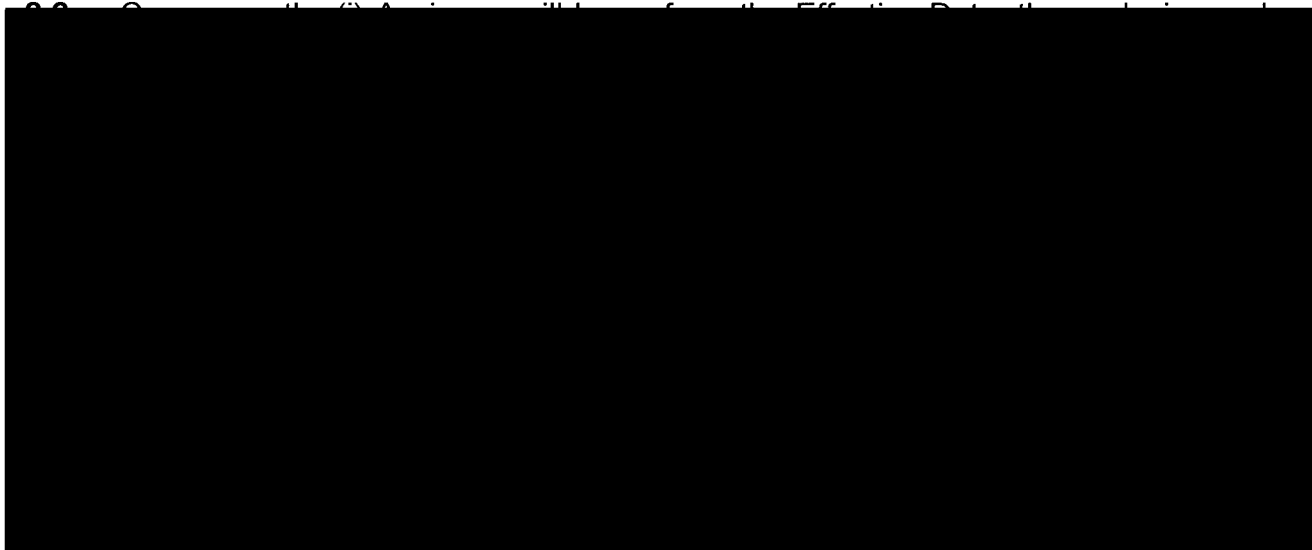




“Trademarks” means trademarks, service marks, trade dress, logos, trade names, corporate names, slogans and other indicia of source or origin, including the goodwill of the business symbolized thereby or associated therewith, all common law rights thereto, all registrations and applications for registration thereof throughout the world, all rights therein provided by international treaties and conventions, and all other rights associated therewith.

**2. ASSIGNMENT**

**2.1** Subject to the terms and conditions of this Agreement, effective as of the Effective Date, Assignor, [REDACTED] hereby irrevocably transfers and assigns to Assignee all right, title and interest throughout the world in and to the Grass Valley Trademarks. Subject to the terms set forth below, Assignee hereby accepts the transfer and assignment of the Grass Valley Trademarks.


