**RELEASE OF TRADEMARKS AND LETTERS PATENT SECURITY  
AGREEMENT**

This agreement dated April 7, 2011, is by and between Steinway & Sons ("Steinway") and UniCredit Bank AG, Cayman Islands Branch formerly known as Bayerische Hypo- und Vereinsbank AG, Cayman Islands Branch as successor in interest to Bayerische Hypotheken - und Wechselbank AG ("UniCredit") and as agent for Fleet National Bank, predecessor in interest to Bank of America. For good and valuable consideration, the receipt and sufficiency of which is acknowledged, the parties hereby agree as follows:


Steinway and UniCredit are parties to a Trademarks and Letters Patent Security Agreement dated August 15, 1990, recorded in the US Patent and Trademark Office at Reel/Frame 0742/0509, and as amended dated August 12, 1992 and recorded in the US Patent and Trademark Office at Reel/Frame 0897/0657.

Unicredit hereby relinquishes to Steinway the continuing security interest in and lien on the Trademarks as referenced in Exhibit A hereto and otherwise assigns, grants and conveys to Steinway any and all rights Unicredit may have in or to the Trademarks in order to revest in Steinway full and unencumbered title to the Trademarks.


